Some questions have been asked about the logistics of Monday's meeting at the HDR|DTA Sacramento Offices:

(1) The first was for a clarification of the directions from I-5—as to why one turned right off Route 5, rather than turning left as maps might suggest. I queried my associates in the Sacramento Office and received the following response (see in ITALIC).

#### From I- 5 North (from north of Sacramento e.g., Sacramento Airport, Woodland)

- 2. At the light, make a right onto Garden Highway.
- 3. At the next light, turn right onto Gateway Oaks Drive, proceed for 0.5 miles.
- 4. Pass Venture Oaks Way on your right and turn into the second driveway on your right. The building marked 2379 will be directly in front of you.

From Highway 5, the Garden Highway exit loops around and one must merge right onto Garden Highway, passing underneath Highway 5 and then one will get to the Gateway Oaks intersection and then it is a right turn onto Gateway Oaks. (2) The second question was to whether tables and electrical outlets would be available for laptops—or if those who had requested paper copies (B&W) and had received them already should bring them along. I am advised that there is a good quantity of electrical outlets in the room being used—and that there is significant conference table space for laptops--that should accommodate most of the need. However, if you do have a paper copy and want to reference it during the meeting, you may want to bring it along with you. As an FYI for those who have requested color copies, they are scheduled to be shipped out the first of next week.
















### **Don Pedro Tour: Hetch Hetchy Aqueduct**





There were a number of items requiring follow-up from our meeting on February 28, 2011. Item [1]: We have completed the doodle poll for meetings. Seventeen (17) of the 86 people polled responded. To all those who responded, I thank you. Based on the results of the poll, we developed the meeting schedule below. Item [2]: Use of an Independent Facilitator -- the Districts responded to this

request on March 7, 2011.

Item [3]: Alternating Meeting Locations – The Districts originally proposed that all meetings be held in the general offices of Modesto Irrigation District (MID). At the Feb 28 meeting, several parties asked that the meeting locations be Sacramento, or be alternated between Sacramento and Modesto, or even possibly the Bay Area. The Districts reevaluated the meeting location. The Districts continue to believe that, on balance, Modesto is a good location. Several agency folks involved are located in Fresno (CDFG), La Grange (CDFG) and Stockton (USFWS), and some Tribal participants have voiced a preference for Modesto. There is very little difference between Sacramento and Modesto for people coming from the Bay Area; only a small number of Participants come from the Bay Area and people from the Project area itself are closer to Modesto. Therefore, on balance, Modesto continues to be a good location. MID has a very good phone system for call-ins, although the Districts strongly encourage in-person attendance at meetings.

Item [4]: Use of Interactive Web Conferencing --- The Districts originally were not in favor of providing interactive web conferencing in order to emphasize the preference for in-person attendance. Some participants asked the Districts to reconsider this. The Districts concern with web conferencing was primarily its potential to be a disincentive to in-person attendance. Secondarily, we were also concerned about being able to consistently deliver on this request. The Districts reevaluated this request. The Districts are willing to provide web interactive conferencing when it fits the meetings purposes (e.g. there are presentations). However, web conferencing will not be available for the April 1 meeting. We are currently assessing the best way to provide this service.

Item [5]: PAD reproduction costs --- Several NGOs voiced their disagreement with the Districts' decision to require reimbursement for paper copies of documents and asked the Districts to reconsider this decision. As a matter of policy, the Districts are committed to using less paper throughout their entire operations. Further, the cost of paper copies can amount to considerable dollars over the course of a relicensing (PAD, PSP, RSP, DLA, FLA, post-FLA filings). The environmental cost of the paper copies, including the shipping thereof, can be significant as well. The Districts have agreed to provide CDs without charge. All documents will be available on the Website; Participants can choose to print only those portions of any document that it has the need for. The Districts believe that minimizing the amount of paper produced in relicensing is a responsible approach.







## **RAKER ACT**


- In 1913 Congress grants CCSF rights of way over public lands necessary for the construction of water supply and power production facilities
- Congress requires CCSF to recognize the Districts' water rights
- Districts to receive no less than 2,350 cfs year-round and 4,000 cfs for 60 days starting April 15 of each year, or natural flow measured at La Grange, whichever is less
- Per the 4<sup>th</sup> Agreement, Districts also receive 66 cfs yearround to meet the La Grange Ditch water right

# **4<sup>TH</sup> AGREEMENT**

- In 1964, Districts and CCSF enter into 4<sup>th</sup> Agreement to construct New Don Pedro
- Increases water storage and hydropower for CCSF, MID, TID
- Relieves CCSF of flood control responsibilities at Hetch Hetchy Project facilities
- Watershed flood control responsibility shifted to Don Pedro
- ACOE participates financially
- Flood control reservation is 340,000 AF
- CCSF water bank is 570,000 AF (plus one-half of flood space encroachment during non-flood season)



#### NOTES

- Don Pedro Lake shall be operated for flood control in accordance with this Flood Control Diagram and the accompanying Emergency Spillway Release Diagram. Reservoir releases shall be made in accordance with the diagram requiring greater release.
- 2. Flood control reservation increases, uniforaly at a rate of 11,700 acra-feet per day from zero requirement on 8 September to the maximum reservation of 340,000 acra-feet by 7 October. The reservation is maintained at 340,000 acra-feet through 27 April after which, unites additional reservation is indicated by the anoment parameters, it will decrease uniformly at a rate of 9,200 acre-feet per day to zero requirement by 3 June.
- Snowelt parameter value is the forecasted natural runoff in thou sand acre-feet of Tuolume River inflow to Don Pedro Lake between the given dat and 31 usly. Dash line parameter extensions below maximum reservation line are used for computation purposes to define gross reservation requirement (before reduction for empty space in upstream reservoirs).
- 4. The fload control reservation in Don Pedro Lake determined from snowell parameters may be decreased by 80 percent of the available empty space in each of Hetch Hetchy and Cherry Valley Reservolrs, respectively, but no reduction will be perarited balow 50,000 acre-feet or the rain fload reservation value, and not more than 705 of the creditable portion of the requirement may be allowed for empty space in Metch Hetchy Reservoir nor more than 305 for empty space in Cherry Valley Reservoir.
- When space available for flood control is less than that indicated by the diagram (after allowing credit for empty space in upstream reservoirs), water shall be released as rapidly as possible without causing flows in Tuolumme River below Dry Creek to exceed 9,000 c.f.s.
- Releases shall not be increased more than 2,000 c.f.s. or decreased more than 1,000 c.f.s. in any 2-hour period except as required by the Emergency Spillway Release Diagram.

#### **1995 SETTLEMENT AGREEMENT**

- Provides for substantial increase in flows over original license for Lower Tuolumne fishery
- Establishes 10 distinct release schedules depending on Tuolumne hydrology
- Hydrology defined in accordance with 60-20-20 San Joaquin Index
- Hydrologic year is October 1 to September 30
- Fishery release "year" is April 15 through April 14
- Initial decision of year type is made in early April



#### **YEAR TYPES**




#### TUOLUMNE RIVER MINIMUM FLOW REQUIREMENT

#### **ANNUAL OPERATIONS**

- "Water First" policy
- Primary factor for reservoir management is water supply, not power

## **SEPTEMBER 8 – OCTOBER 7**

- Flood Control Rule Curve reservoir no higher than 801.9 feet by October 7
- Irrigation deliveries from Don Pedro are normally sufficient to bring reservoir elevation to at least 801.9 feet
- For example, July to October inflow of 60,000 AF; irrigation, M&I, and fishery flows 500,000 ; evap of about 50,000 AF ; net outflow of 360 TAF

# OCTOBER 7 – NOVEMBER 30

- Flood management season maintain water levels below 801.9 feet
- Pulse flow to attract upstream migrants depending on water year type (occurs approximately 70% of the years)
- 45-Day Period (typically October 17 through November 30):
  - $\circ$  Fluctuations controlled so as not to exceed 10 inches daily
  - For 2 hours per day, less than 18-inch increase
- Stable flows is a goal for this period; therefore may leave some buffer between actual reservoir elevation and 801.9 feet
- Irrigation deliveries can extend into November
- M&I delivery requirements

#### DECEMBER 1 – MARCH 31

- Flood management season maintain water levels below 801.9 feet
- Monitoring snowpack, weather patterns, and projecting runoff on a daily and sub-daily basis
- Consider need for carryover storage and effects of CCSF water bank
- Maintain flows at the Modesto gage below 9,000 cfs
- If encroachment occurs, elevate storage above 801.9 feet within 12 days if possible and within Corps-suggested release targets
- May "pre-release" flows based on inflow forecasts
- M&I deliveries
- Irrigation deliveries begin as early as February (infrequently there are January deliveries) depending on winter conditions
- Fill Turlock Lake and Modesto Reservoir

#### **APRIL – JUNE**


- Flood management season and reservoir filling above 801.9 feet starting on April 27, if water is available and there is no snowmelt parameters in effect
- Monitoring snowpack, weather patterns, and projecting runoff on a daily and sub-daily basis
- Pulse flow for outmigrants (all years; varies from 11,000 AF to 90,000 AF)
- Irrigation deliveries
- M&I deliveries
- Calculate water year type circa April 10 for upcoming fishery year flows (April 15 thru April 14); defines both pulse flows and continuous flows



- Post-flood season reservoir level can be as high as 830 feet
- Irrigation deliveries peak
- M&I delivery requirements



#### **Inflow Into Don Pedro- 2006**



#### LA GRANGE DAM

- Constructed in 1893 to divert irrigation water to TID and MID
- Normal water surface elevation of about 295 feet
- TID canal capacity = 3,000 cfs; currently limited to 2,500 cfs for canal safety reasons
- MID canal capacity = 2,000 cfs
- TID canal restricts flow fluctuations to 18 MW/hr or 500 cfs/hr
- Turlock Lake actual capacity 36,000 AF; normally operated between 28 TAF and 32 TAF
- Modesto Reservoir capacity 28,000 AF
- Turlock Lake and Modesto Reservoir operations balance demand ("calls") for irrigation deliveries with timing of supply; canal operations require ability to fluctuate the reservoir to a degree

## **LA GRANGE OPERATIONS**

- Structure allows the Districts to divert water from the Tuolumne River into the TID and MID canals
- Reservoir storage less than about 100 AF, so reservoir fluctuations are minimal
- Canal flows controlled by gates at the entrances to each canal
